**Early Withdrawal Refund**

A refund is based on based on the attendance of the student and contingent upon provision of written notice submitted in advance. (Please see page 21 of Parent-Student Handbook)  
**This refund applies solely to tuition. Attendance during any part of a quarter requires payment for the entire semester. Other school fees are non-refundable.**

Families with more than one child at the school will receive a reduction in enrollment and re-enrollment fee of **NAf.500** for the second child and **NAf.1000** for the third child. No enrollment or re-enrollment fee will be charged for additional siblings. Enrollment and re-enrollment **fees are non – refundable. Enrollment fees are payable upon acceptance.**

*Capital Levy Certificates (CLCs) are required when a company pays the fees. Late payments outside the above arrangements will be charged an additional **2% per month late payment fee.***
