## **Health Care Release**

In order to provide the best possible care for my child, I understand that special health care needs or chronic conditions will be shared with appropriate school personnel. In the event of a life-threatening situation or critical injury, I understand that the school has my permission to take appropriate emergency medical action. Additionally, I understand that the school will make every effort to notify me immediately. To this end, I will ensure that the school has my most current phone numbers on record.

## **Photo/Videotape release**

I give permission for my child to be photographed, interviewed or videotaped for stories/articles promoting our school. These stories, photographs/videotapes may appear in the media. I consent for the release of photographs/videotape to the media in school related coverage.

## **Yearbook**

I give permission for my child's picture to be included in the school's yearbook.

## **Web Page**

I give permission for photographs and exemplary classroom projects to be posted on the school's web page which can be accessed on the internet at [www.isc.cw](http://www.isc.cw). In posting a photograph or exemplary classroom projects of a student, the school is careful not to associate a student's full name in such a way that it can be identified with a photograph of the student.

## **Student Dismissal Information**

In order for the school to safeguard dismissal of my child, I understand that I need to inform the school of any changes in regular school departure procedures of my child. I will need to inform either the student's teacher(s) or the main office of a change in routine.

## **Student Drivers and Student Passengers**

I understand that if my child has a driver's license and drives to school there are specific requirements to be complied with as stipulated in the handbook, and that I have to fill out a Student Driver Form. If I have a child who is allowed to ride as a passenger with a student driver, I understand that I have to fill out a Student Passenger Form.

## **Field Trip Permission**

Field trips are considered part of the student's regular school program. All students are expected to attend field trips. Failure to attend will be recorded as unexcused absence. My son/daughter has permission to participate in field trips during school hours when accompanied by his/her teachers. I understand that a separate form will be sent for trips that include swimming, boat rides, horseback riding and the like.

**Agreement for Student Use of Technology**
